- 1. You acknowledge and agree that HSBC will use reasonable endeavours to carry out this Order but does not guarantee that bonds will be bought or sold at all or at such quantity and/or price according to this Order. In addition, HSBC may at its discretion, but has no obligation to, carry out this Order partially.
- 2. You agree and accept that daily bid/offer price of bonds is not available for this Service. However, indicative bid price for sale order may be provided upon request.
- 3. You agree and accept that this Order may be carried out on the date of this Order (the "Transaction Date") only and this Order will lapse if for whatever reason HSBC is unable to carry out this Order before expiry of the Transaction Date.
- 4. If this Order is carried out, you agree and accept that settlement of transaction will be on the third or later business day after the Transaction Date.
