

Terms and Conditions of HSBC Premier Staying Privileges

General Terms and Conditions

- 4. To enjoy the Promotion, Eligible Customers should email signaturehomes@shkp.com or contact Signature Homes General Hotline +852 9228 2931, and specify "HSBC Premier Staying Privileges" for enquiries. When making enquiries, Eligible Customers is required to send the proof of their valid HSBC Premier status profile via Eligible Customers' HSBC HK Mobile Banking App indicating with full customer name, or any other information as may be required to Signature Homes staff. Eligible Customers is required to login the HSBC HK Mobile Banking App on site for Signature Homes staff to validate his/her identity and membership. The Staying Privileges (as defined in paragraph 8 hereinbelow) will only be granted after successful identity verification by Signature Homes' staff and subject to the fulfillment of the requirement in General Terms and Conditions Clause 8.
- 5. Eligible Customers must be a new tenant, occupant or licensee of Signature Homes, who has not made any direct or indirect contact with Signature Homes' staff or referred to Signature Homes via any other sources, including property agency, regarding the concerned premises within a period of six months before the date of enquiry.
